AN ORDINANCE AMENDING REGARDING MOTORIZED  
VEHICLES ON VILLAGE STREETS

WHEREAS, the Village President and Board of Trustees of the Village of Wyanet, Illinois Have heretofore passed an ordinance entitled "An Ordinance Regarding Motorized Vehicles on Village Streets", and

WHEREAS, it is necessary to amend said ordinance by adding item IV:

IV. All operators/owners of recreational vehicles must abide by the attached Village of Wyanet ATV rules and Village of Wyanet ATV Registration requirements.

EFFECT OF AMENDMENT:

Except as to the amendment as hereinabove provided, all provisions of the aforesaid ordinance and any other amendment thereto shall remain in full force and effect.

EFFECTIVE DATE:

This ordinance shall be in full force and effect from and after its passage and publication according to law.

SEPARABILITY:

It is the intention of the Village Board that each separate provision of the amendment shall be deemed independent of all other provisions herein, and it is further the intention of the Village Board that if any provisions of this amendment declared invalid, all other provisions thereof shall remain valid and enforceable.

## VILLAGE OF WYANET ATV RULES

- Driver must be at least 16 years old AND have a valid driver's license

\*A special permit will be granted by the Chief of Police & the Village Board or Village President

- No child under the age of 16 shall ride in front of the driver
- Driver must follow all traffic laws and traffic signs
- Must obey a 20mph speed limit at all times
- All 4 wheelers are limited to 2 riders (front & back)
- All vehicles must have a head light and tail/brake light
- All owners must register all ATV's, golf carts, side by side, two, three or tracked vehicles.
- All owners must purchase AND display on the vehicle a Wyanet Village ATV permit, \$15.00 per unit per year.
- No riding on sidewalks, except for the use in plowing snow.

\*Any owner of an ATV, two, three wheeling or tracked vehicle is responsible to advise persons borrowing unit of the ATV rules

ORDINANCE NO. 0-10-10-12-14

AN ORDINANCE REGARDING MOTORIZED VEHICLES ON  
VILLAGE STREETS

WHEREAS, the Village President and Board of Trustees, along with the Wyanet Police Department, have determined that an ordinance needs to be passed regarding use of non-licensed motor vehicles on village streets.

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

- I. All recreational vehicles operated on the village streets must be operated only by persons with a valid driver's license.
- II. Stop signs and traffic laws must be complied with . Speed limit not to exceed 20 miles per hour.
- III. Anyone found to be in violation of this ordinance shall be subject of a fine not to exceed \$100.00.
